Dear Members

This serves to inform you that the Minister of Employment and Labour has published and approved the Council's Special Sick pay fund levy which is to be paid twice in three years (Triennially) during January 2020 and January 2023 in the Government Notice R. 2571 of 28 September 2019 in terms of Section 32 of the labour Relations Act.

All employers in the total scope of the Council are legally obliged to pay the Special sick pay on behalf of employees employed at the company as at payment due date (31 January 2020 and 31 January 2023) at the rate of R167.00 per employee.

Please note this special levy will only be applicable from January 2020 to January 2023. If there are to be any extensions, such will be communicated to all Stakeholders

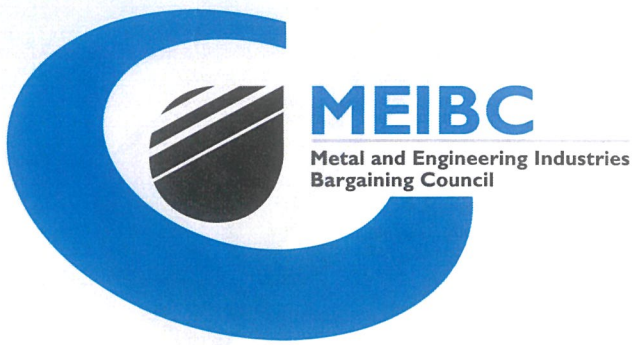
